6. Pre-bid meeting shall be held at **Province Transport Operation and Management Board, Hetauda at 1:00 PM, 29th April, 2021.**
7. Electronic bids must be submitted to the office through Nepal Governments centralized e-procurement portal PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Hrs. on 14th May, 2021. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs. on 14th May, 2021 at the office of PTOMB. Bids must be valid for a period of 120 days after bid opening and must be accompanied by as canned copy of the bid security in pdf format amounting to a minimum of as mentioned in the table above in para 2, which shall be valid till **11th October 2021.**
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
